Rules of Entry

1. Early Bird Submission Fee \$15 (Dec 1st - April 19th)
Regular Submission Fee \$20 (April 20th - May 14th)
Fee must accompany each film submitted.
2. The Submitter must own full legal rights over the content of each submitted film or have legally obtained written permission for use of such film content by the owner.
3. MCA-TV will accept film submissions from any filmmaker.
4. Films may be any length of time and any genre.
5. All films will be accepted and submitted for judging, MCA-TV retains the sole legal right to cablecast or not cablecast submissions. If MCA-TV decides to cablecast a submission, the schedule of the airing of the submission is the sole responsibility of MCA-TV.
6. The Submitter must comply with all federal, state and local laws and regulations pertaining to the content of the film submission. The Submitter must agree in writing to indemnify MCA-TV and Moon Township from any claims associated with the content of the film submission.
7. The film must be submitted in DVD format.
8. The Film Fest will be cablecast May 29th.
Comcast channel 14 and Verizon channel 35.
9. Films will be selected for awards by judges chosen by MCA-TV at MCA-TV's sole discretion. If any judge has a business or personal relationship with any submitter, that judge shall excuse him or herself from judging that submitter's film.
10. No Refunds shall be granted for any film that is not aired or for any film that does not receive an award.
11. By filling out the Application Form and Producer Release, the submitter agrees to the rules outlined above.

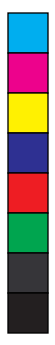




MCA-TV COMMUNITY PRODUCERS AGREEMENT AND RELEASE

In consideration for the privilege of using certain video, audio, and/or production equipment owned or managed by Moon Community Access Television (“MCATV”) and/or producing certain programming to be cablecast over the cable system to residents of Moon Township, I hereby agree to the following terms and conditions:

1. I have read the MCATV Rules and Regulations and agree to fully comply with all of the terms and conditions contained therein. If I fail to comply with any such term or condition, I understand that I am subject to certain penalties that may be imposed by MCATV.
2. I agree to pay the costs of repair or replacement of any equipment or materials owned and/or managed by MCATV that have been damaged or lost while such equipment or materials is being used by me or by my volunteers. I agree to read and sign a Sign Out and Release for MCATV Equipment for any equipment or materials owned or managed by MCATV that I wish to remove from MCATV premises.
3. I agree to indemnify and hold harmless MCATV, Moon Township, and Comcast of Pennsylvania II, Inc., their elected and appointed officials, officers, agents and employees, and their successors and assigns, from any and all liability or other injury, including reasonable attorneys’ fees and costs, arising from or in connection with claims for failure to comply with applicable federal, state, or local laws or regulations that result from any programming or material I have produced or recorded or my use of any equipment or facilities owned or managed by MCATV. Such claims for failure to comply with applicable federal, state, or local laws include, but are not limited to, the following: claims for libel, slander, invasion of privacy or the infringement of common law or statutory copyright; claims for unauthorized use of any trademark, trade name, or service mark; claims for breach of contractual or other obligations owing to third parties; claims for obscenity or indecency; and claims for any other injury or damage in law or equity.
4. I certify that I am at least eighteen (18) years of age. Any community producer under eighteen (18) years of age must have this Agreement and Release signed by a parent or guardian, who shall assume full responsibility for the terms and conditions contained herein.
